CLASS REGULATIONS Short Stirrup, Pony Hunter, Children's Hunter, Adult Amateur Hunter, Junior/Amateur Hunter, Pre-Children/Adult Hunter, Age Group Equitation and NCHJA Equitation Medals are run in accordance with NCHJA rules. Schooling Hunter and Hunter Warm-Ups are open to all horses and ponies. Young Entry is open to junior riders in their first 2 years of showing. Long Stirrup is open to riders over 12 years of age. Walk/Trot is open to riders 12 and under. Pony Hunter will be split if there are at least 3 small/mediums and 3 larges. One Minute Rule may apply.
